Under this warranty cover, the Seller guarantees the appliance registered on this invoice against faulty workmanship or material only, for a period of 1 (one) year unless otherwise stated below from registration date under normal use and service subject to the terms and conditions set out herein. For the avoidance of doubt, nothing stated herein nor any repairs or replacement effected during the applicable warranty period shall extend the said applicable warranty period.

### 3. Return of product(s)

- 1. Product(s) once sold cannot be returned unless the product(s) show manufacturing defects and are brought by the Customer to the Seller within 5 calendar days and for Huawei and Samsung product(s), within 7 calendar days from the date of purchase. The product(s) shall be replaced only after verification by the Seller's After Sales Services.
- 2. The customer may only return the product(s) within the period specified above provided that the product(s):
  - (i) have not been utilised: and(ii) are in the same condition as when they were sold.
- 4. This warranty is not transferable and only covers the original purchaser registered on this invoice.
